

# REGULATIONS

*Made under section 452*

## THE COMPANIES (FEES PAYABLE TO REGISTRAR) REGULATIONS, 2005

1. These Regulations may be cited as the Companies (Fees payable to Registrar) Regulations 2005, and shall come into force on the date of publication. Citation

2. In these Regulation, “the Act” means the Companies Act 2002. Interpretation  
Act No. 12 of 2005

3. The Schedule to these Regulations has effect with respect to the fees payable to Registrar of Companies for the performance of his functions under the Act as follows: Fees

## SCHEDULE

<i>Function</i>	<i>Amount</i>
For the registration of a company having capital whose nominal share capital is:	
(a) not more than Tshs.20,000/= but not more than Tshs.500,000/=	50,000/=
(b) more than Tshs.500,000/= but not more than Tshs.1,000,000/=	80,000/=
(c) more than Tshs.1,000,000/= but not more than Tshs.2,000,000/=	100,000/=
(d) more than Tshs.2,000,000/= but not more than Tshs.3,000,000/=	120,000/=
(e) more than Tshs.3,000,000/= but not more than Tshs.5,000,000/=	150,000/=
(f) more than Tshs.5,000,000/= but not more than Tshs.10,000,000/=	180,000/=
(g) more than Tshs.10,000,000/= but not more than Tshs.30,000,000/=	200,000/=
(h) more than Tshs.30,000,000/= .....	300,000/=
2. For the registration of a company not having a share capital where the number of members as stated in the Articles of Association:	
(a) does not exceed 25 .....	50,000/=
(b) exceeds 25 but does not exceed 50 .....	60,000/=
(c) exceeds 50 but does not exceed 100 .....	70,000/=
(d) exceeds 100 but does not exceed 150 .....	80,000/=
(e) exceeds 150 but does not exceed 200 .....	90,000/=
(f) is unlimited .....	120,000/=

3. For reservation of a company name .....	50,000/=
4. For company name change .....	15,000/=
5. For the receipt and/or registration by Registrar of any document which under the Act is to be delivered to him .....	15,000/=
6. For the late filing/registration fee to be paid to the Registrar of any document delivered to him (per month or part thereof) .....	1,500/=
7. For filing of Annual Returns .....	15,000/=
8. For certification of any document, per page .....	2,000/=
9. For making search in any file/perusal .....	2,000/=
10. For obtaining a written search report per file .....	15,000/=
11. Fees payable by a company to which Part XII of the Act applies:	
(a) For the registration of certified copy of a charter, statute or memorandum and articles of the company, or other instrument constituting or defining the constitution of the company .....	\$ 500
(b) For registration of filling any document required to be delivered to the Registrar under Part XII of the Act/other than the balance sheet ....	\$ 150
(c) For filling of Balance Sheet .....	\$ 150
(d) For late filing/registration fee to be paid to the Registrar of any document delivered to him out of time (per month or part thereof) .....	\$ 15
