Citation and  
Commencement

1. -(1) These Regulations may be cited as the Immigration (Amendment) Regulations, 2012, and shall be read together as one with the Immigration Regulations herein after referred to as the "principal Regulations".

(2) These Regulations shall be deemed to have come into operation on the first day of August, 2012.

A-5	Large scale agriculture and animal husbandry	Persons intending to engage into agriculture or animal husbandry.	First issue and renewal	2,000	
A-6	Artisans	Persons intending to engage into activities like tailoring, goldsmiths, cobblers and engineering works.	First issue and renewal	2,000	
A-7	Small scale farming, trade, business and fishing	Persons in the country engaged in small scale farming, trade, business or fishing.	First issue and renewal	1,000	
A-8	Peasants	Persons who have resided for a long time in the country as peasants, pastoralist and other legally recognized small scale activities.	First issue and renewal		10,000/=
